NGOCSD General Membership Meeting: Friday, May 15th, 2015



Nobel Laureate Professor Wangari Muta Maathai was born in Nyeri, Kenya in 1940 and was the first woman in East and Central Africa to earn a doctorate degree. Wangari Maathai obtained a degree in Biological Sciences from Mount St. Scholastica College in Atchison, Kansas (1964). She subsequently earned a Master of Science degree from the University of Pittsburgh (1966). She pursued doctoral studies in Germany and the University of Nairobi, obtaining a Ph.D. (1971) from the University of Nairobi where she also taught veterinary anatomy. Ms. Maathai was active in the National Council of Women of Kenya from 1976-87 and was its chairman from 1981-87. During this time, she introduced the idea of planting trees with the people in 1976 and continued to develop it into a broadbased, grassroots organization whose main focus is the planting of trees with women groups in order to conserve the environment and improve their quality of life. Through the Green Belt Movement she has assisted women in planting more than 20 million trees on their farms and on schools and church compounds. Professor Maathai was internationally recognized for her persistent struggle for democracy, human rights and environmental conservation. She addressed the UN on several occasions and spoke on behalf of women at special sessions of the General Assembly for the five-year review of the earth summit. She and the Green Belt Movement received

numerous awards, most notably the 2004 Nobel Peace Prize. Others include The Sophie Prize (2004), The Petra Kelly Prize for Environment (2004), The Conservation Scientist Award (2004), J. Sterling Morton Award (2004), WANGO Environment Award (2003), Outstanding Vision and Commitment Award (2002), Excellence Award from the Kenyan Community Abroad (2001), Golden Ark Award (1994), Juliet Hollister Award (2001), Jane Adams Leadership Award (1993), Edinburgh Medal (1993), The Hunger Project's Africa Prize for Leadership (1991), Goldman Environmental Prize (1991), the Woman of the World (1989), Windstar Award for the Environment (1988), Better World Society Award (1986), Right Livelihood Award (1984) and the Woman of the Year Award (1983). Professor Maathai was also listed on UNEP's Global 500 Hall of Fame and named one of the 100 heroines of the world. In June 1997, she was elected by Earth Times as one of 100 persons in the world who have made a difference in the environmental arena. Professor Maathai also received honorary doctoral degrees from several institutions around the world: William's College, MA, USA (1990), Hobart & William Smith Colleges (1994), University of Norway (1997) and Yale University (2004). Professor Maathai served on the boards of several organization including the UN Secretary General's Advisory Board on Disarmament, The Jane Goodall Institute, Women and Environment Development Organization (WEDO), World Learning for International Development, Green Cross International, Environment Liaison Center International, the World WIDE Network of Women in Environmental Work and National Council of Women of Kenya. In December 2002, Professor Maathai was elected to parliament with an overwhelming 98% of the vote and was subsequently appointed by the president as Assistant Minister for Environment, Natural Resources and Wildlife in Kenya's ninth parliament. Professor Maathai left us in September of 2011 and we miss her dearly.



Mr. Arthur Amaya Andambi, Minister Counsellor of the Permanent Mission Kenya to the United Nations. In October 2014, Mr. Andambi was posted to the Kenya Mission to the UN in New York as Minister Counsellor where he is in charge of Second Committee matters and performs Administrative duties as Head of Chancery. Mr. Andambi was recruited by the Public Service Commission of Kenya in February 1990 as an Assistant Secretary. He worked mainly at the Ministry of Home Affairs where he performed duties of a Special Programme for Refugees. He worked with the United Nations High Commissioner for Refugees to ensure refugees were given the status they deserved in Kenya. He was also involved in the establishment of refugee camps in the country and generally worked with other aid agencies which were involved in the care and protection of refugees and forced migrants. Mr. Andambi worked briefly at the then Standing Committee on Human Rights in Kenya where the rights of Kenyans particularly those in prisons were protected. He also worked briefly at the Ministry of Public Works and the Ministry of Lands during this period where he served as a Personal Assistant to the then Permanent Secretary. Mr. Andambi has a Master's Degree in International Studies from the University of Nairobi. Graduated in September 2008 and had graduated in 1989 with a Bachelor's Degree (First Class Honors) in Sociology and Political Science from MS

University of Baroda in Gujarat State, India. Mr. as deployed to the Ministry of Foreign Affairs and posted to the Africa and AU Directorate where he dealt with African Union matters. In October 2008, he was posted to the Kenya Embassy in Stockholm, Sweden where he dealt with relations between Kenya and Sweden, Norway and Iceland. He worked as Deputy Head of Mission and Head of Chancery where he was in charge of the general administration of the Mission. In November 2012, he returned to Nairobi where he was reassigned duties as Deputy Director at the Africa and AU Directroate. His work there involved promoting relations between Kenya and other African Union. Was later transferred to Europe and Commonwealth Directorate in the same capacity and his work involved promoting relations between Kenya and European countries including the Commonwealth.



Ms. Lopa Banerjee, Chief of the Civil Society Section at UN Women, a position she has held since January 2012. She is based in New York and leads UNWomen's work on strengthening civil society contribution, participation and influence in norm setting and intergovernmental policy discussion and decision processes. A gender and human rights thematic expert with substantive experience in social policy and governance issues across Asia and Africa, she has worked for over 3 decades in international development, policy advocacy, communication and partnership building across the UN and in the private sector. She has had a long career with the United Nations. Prior to the UN she worked with the private sector as well as with civil society, in India. Before joining UN Women, she worked with UNDP and OHCHR in South Africa and UNICEF in Iran (the Islamic Republic of), Bangladesh and New York. In India, she worked for several years in communication, research and advocacy. She has worked with civil society in diverse spaces and facilitated UN-civil society engagement in South Africa, Iran and Bangladesh. Her areas of specialization include policy analysis and advocacy, partnership development and engagement, and Gender and Human Rights Based Programming and training. She speaks English, Hindi, Bengali and is learning Spanish.



Ms. Wanjira Mathai, Director, wPOWER, Chair of the Green Belt Movement and Project Director for the Wangari Maathai Institute for Peace & Environmental Studies. Prior to this she directed International Affairs at the Green Belt Movement (GBM), where she managed International outreach and resource mobilization. For 6 years prior to joining GBM, Ms. Mathai worked as Senior Program Officer at the Carter Presidential Center, Atlanta, Georgia (USA), monitoring & evaluating disease eradication programs. Since 2002, Ms. Mathai directed International Affairs at GBM, which was founded by her mother, the late Nobel Peace Laureate Wangari Maathai. Today Wanjira directs the new Partnership for Women's Entrepreneurship in Renewables (wPower) Hub at the Wangari Maathai Institute. Wanjira is the Chair of the Green Belt Movement and sits on the Board of WMI. She is also a World Future Councilor, Advisory Council Member (Global Alliance for Clean Cookstoves), is a member of the Global Restoration Council and is a member of the Earth Charter International Council. Wanjira is Kenyan and a graduate of Hobart & William Smith Colleges (USA). She earned graduate degrees in Public Health and Business from Emory University's Rollins School of Public Health and Goizueta School of Business (USA).

Dr. Margaret (Peg) Snyder, Founding Director of UNIFEM (1978-89), Co-Founder of the African Centre for Women and Head of the Voluntary Agencies Bureau of the United Nations Economic Commission for Africa (ECA 1971-78). She was an international election observor in Ethiopia, Uganda, and Tanzania and a Fulbright scholar at Makerere University, Uganda (1990s); her PhD is from the University of Dar es Salaam, Tanzania. She is Co-Founder and Vice President emeritus of the Board of the Sirleaf Market Women's Fund and Treasurer emeritus of the Green Belt Movement International. Her recent books are *Transforming Development: Women, Poverty and Politic* (a history of UNIFEM), *African Women and Development: A History* (co-authored with Mary Tadesse), *Women in African Economies: from Burning Sun to Boardroom* and *Above the Odds: a Decade of Change for Ugandan Women Entrepreneurs* (with Sarah Kitakule); she has written chapters in several other books.



Ms. Mia MacDonald, Chair of the Green Belt Movement International – North America and Founder and Executive Director of Brighter Green. Based in New York. Ms. MacDonald is a public policy analyst and writer who has worked as a consultant to a range of international non-governmental organizations; including the Ford Foundation, the World Wildlife Fund, the Green Belt Movement, the Sierra Club, and Save the Children as well as several United Nations agencies, among others—on issues of environment, gender, sustainable development, women's rights and gender equality, reproductive health and population, and conservation and animal protection. She has published many articles in popular and environmental media, authored a number of policy papers and reports, and has contributed to four books, including Nobel Peace Laureate Wangari Maathai's best-selling autobiography, *Unbowed*. She is a Senior Fellow of the <u>Worldwatch Institute</u> and has taught in the human rights program at Columbia University's School of International and Public Affairs and the environmental studies program at New York University. She has served on the board of <u>Farm Sanctuary</u> and <u>Food</u> Empowerment Project. She currently chairs the board of the <u>Green Belt Movement International – North America</u>. She received a Master's Degree in Public Policy from the Kennedy School of Government at Harvard University and a B.A. with honors from Columbia University.



Mr. Ochoro E. Otunnu, J.D. is a Board Member of the Green Belt Movement International, US. He serves as Principal and General Counsel of LCN Capital LLC. Mr. Otunnu has extensive legal and private equity experience in fund formation, deal structuring, financing, corporate governance and securities law within developed and emerging markets. His complex transaction and negotiation work includes assisting in the development of the Angola Stock Exchange. Mr. Otunnu combines his deep commercial expertise with a lifelong passion and commitment to human rights and social and economic development. His pro bono legal work includes the 2004 constitutional case that ended one-party rule in Uganda, the defence of Koigi Wamwere who was emprisoned twice in Kenya for his opposition to the regimes of Jomo Kenyatta and Daniel arap Moi as well as acting as counsel to American journalist Taylor Krauss, who was detained in Uganda for covering pro-democracy demonstrations. Throughout his career, Mr. Otunnu has been extensively involved in development work. He formed and became Executive Director of Africa AIDS Initiative (AAI). Mr. Otunnu also served as Program (UNDP) and supported the Kofi Annan team that brokered a peace deal in Kenya following post-election violence in 2008. He

also advised Rory Kennedy in the production of the HBO award-winning documentary film Pandemic: Facing AIDS. Mr. Otunnu serves as a Member of Advisory Board of Impact Investment Partners LLP. In 1989 he co-chaired the United Nations mission that developed the blueprint for the UN international assistance to the nongovernmental sector in Namibia, and created the group at Yale Law School that partnered with the Pan-African Parliamentarians to draft model HIV/AIDS legislation for Africa. Mr. Otunnu holds a J.D. degree from Columbia Law School; an M.A. in Philosophy, Politics, and Economics (PPE) from Oxford University; and an A.B. in Government from Dartmouth College.



Ms. Eleanor Blomstrom, Program Director/ Head of Office, Women Environment & Development Organization. As Program Director at WEDO, Ms. Blomstrom manages internal and external relationships and partnerships, including with staff, funders and coalition and project partners. She works closely with program staff in strategic development, implementation and monitoring of WEDO programs and projects. With a particular focus on sustainable development, climate change and urbanization, her work incorporates research, capacity building, and global-level advocacy at multiple UN fora, including the UNFCCC and related to the post-2015 development agenda. Supporting WEDO's long-standing role of facilitating space for women's organizing and action, she represents WEDO as organizing partner of the Women's Major Groups for Sustainable Development and for Disaster Risk Reduction. Prior to WEDO, she worked on climate change projects ranging from green roofs to waste management to adaptation, and on community development projects in the areas of agriculture and women's empowerment in Nicaragua and Nigeria. Her current work is informed by a professional background in bilingual elementary education with a focus on race and gender equity in public schools. Ms Blomstrom holds a Masters in International Affairs in Urban and Environmental Policy from Columbia University's School of International and

Public Affairs and a Bachelors degree in Environmental Sciences.



Ms. Rita Henley Jensen, Founder and Editor-in-Chief of Women's eNews which is a daily, online news service covering issues of particular concern to women and girls. Launched in 2000, Women's eNews has won 40 journalism awards including the PASS Award from the National Council on Crime and Delinquency and the Rosa Cisneros award from the International Planned Parenthood Federation, Western Hemisphere Region. Jensen also was named by the New York Daily News one of the 100 most influential women in New York and she has just been named one of Folio magazine's Top Women in Media, Corporate Visionary, to be celebrated in June. She is a former senior writer for the National Law Journal and columnist for The New York Times Syndicate and has received an armload of awards, including the Columbia University Graduate School of Journalism Alumni award. Jensen is also a survivor of domestic violence and a former welfare mother who earned degrees from Ohio State University and Columbia Graduate School of Journalism. Mr. Ilmi Granoff, J.D. is a Senior Research Fellow at Overseas Development Institute. ODI is leading the institute's work on green growth. environmental science and international relations from Yale University, and received his *juris doctor* from New York University School of Law. He holds a bachelor's degree (High Honors) from Swarthmore College.

Mr. Ravi Karkara, Co-Chair, World We Want 2015 Policy and Strategy Group; Global Advisor on Youth + Partnership with United Nations Millennium Campaign and UN-HABITAT, based in New York. He is the lead author of the groundbreaking report "Youth 21: Building the Architecture of Youth Engagement in the UN System," by UN-Habitat, which contributed to the creation of United Nations Secretary General's Envoy on Youth. Ravi represented UN-HABITAT as the Co-chair of the UN Interagency Network on Youth Development. Government of Sri Lanka appointed him as the Global Advisor to the World Conference on Youth in 2014, focusing on youth perspective in developing post-2015 development agenda. He has relentlessly supported United Nations SG's My World 2015 survey in reaching close to 5.5 million young people. Ravi has been co-chairing the Policy Strategy Group for World We Want 2015 - a UN and CSO co-led post-2015 Big Data-Curation-Visualization global conversation platform. He is serving as Strategic Adviser Partnership Beijing+20, Office of the Assistant Secretary-General/Deputy Executive Director, UN-Women. Masters in Divinity from Union Theological Seminary, in the City of New York and has done graduate work at Yeshiva, Seton Hall and Rutgers Universities on the Holocaust, Genocide, Trauma and family Systems.
