Mr. Satya S. Tripathi is a UN Assistant Secretary-General and Head of the UN Environment New York Office. Mr. Tripathi is a development economist and lawyer with over 35 years of varied experience, he has served with the UN since 1998 in key positions in Europe, Asia and Africa in the areas of Climate Change, Human Rights, Democratic Governance and Legal Affairs. He was Chair of the Committees on Laws, Treaties and Administrative matters for the UN-mediated Cyprus unification talks in 2004; UN Recovery Coordinator for Aceh and Nias where he facilitated international cooperation and funding of over US\$ 7 billion for post-tsunami and post-conflict recovery efforts in support of the Indonesian government and affected populations; and Executive Head of UNORCID, a UN System Office of 10 UN Agencies established by the UN Secretary General in 2011 to facilitate the implementation of a US\$ 1 Billion REDD+ partnership between Indonesia, Norway and other stakeholders on climate change mitigation and adaptation through the conservation of forests and preservation of peat-land and bio-diversity. Mr. Tripathi was instrumental in

establishing the Tropical Landscapes Finance Facility (TLFF) in Indonesia in 2016 and the Sustainable India Finance Facility (SIFF) in 2017 to leverage 'private finance for public good' at mega-scale to achieve transformative social and environmental impact in developing countries. He previously served on the World Economic Forum's Global Advisory Council on Forests; and in India as a member of its national civil service.



Ms. Natalie Samarasinghe, Deputy to the Special Adviser on Preparations for the Commemoration for the UN's 75th Anniversary. Ms. Samarasinghe served as Chief Speechwriter for the President of the 73rd Session of the United Nations General Assembly. She has been the Executive Director of the United Nations Association – UK (UNA-UK) working with United Nations Association, since 2006. She is currently on leave of absence from UNA-UK, As the first woman to head the United Nations Association-UK, she has had overall responsibility for UNA-UK's programmes, with particular focus on advocacy, strategic communications, human rights, peace and security, and UN reform, including the Together First campaign on the Organization's 75th anniversary in 2020. Ms. Samarasinghe is a regular commentator on UN issues, and has edited or contributed to publications including the SAGE Major Work on the UN, The Oxford Handbook on the United Nations and the "Global Goals" and "Climate 2020" series. She has advised or served as a trustee for organisations including the Association of Citizenship Teaching, Sri Lanka Campaign

and the Doc Society film foundation. In 2013, she co-founded the 1 for 7 Billion campaign for a more transparent and inclusive process to select the UN Secretary-General. In 2018, she was awarded a prize by the Global Challenges Foundation for a proposal to open up UN decision-making and delivery to external stakeholders.



Prof. Jan Dash PhD is Editor of the World Scientific Encyclopedia of Climate Change (2020). He was Directeur de Recherche at the Centre de Physique Théorique in Marseille France, and published over 60 scientific papers. Subsequently, he worked for many years on quantitative finance and risk management. His book on the subject includes a chapter on Climate Change Risk Management. He was Adjunct Professor at the Courant Institute, NYU. He did the math behind the Bloomberg Climate Clock and spoke on a panel at the 2015 Paris Climate Conference.
