H.E. Mr. Lot Thauzeni Pansipadana Dzonzi, Deputy Ambassador and Deputy Permanent Representative of the Permanent Mission of Malawi to the United Nations in New York. Ambassador Dzonzi is the past Vice Chairperson of the 55th and 56th Sessions of the UN Commission of Social Development. Prior to his deployment in New York he was the Inspector General of Police. He worked with the Malawi Police Service for 28 years. He is an author of several books among which are; Reaching Out Reach Higher, of Mountains and Valleys, Success is Spelt Sweat Equity and Soaring With the Eagles. He is also a motivational speaker and a leadership and personal growth trainer.



Mr. Reinhard J. Krapp, Minister and Head of the Economic and Financial Affairs Department at the Permanent Mission of Germany to the United Nations. Mr. Krapp has been the Minister of Economic and Financial Affairs at the Mission of Germany since July 2014. He served as Deputy Ambassador at the German Embassy in Sofia, Bulgaria from 2011 to 2014. He was Head of Division for International Environment Policy from 2006 to 2011 in the Berlin Foreign Office. He served as Head of Legal and Consular Department in the German Embassy in Moscow 2003 to 2006. His focus was on Sustainable Development from 1999 to 2003 at the Permanent Mission of Germany to the United Nations. He went to Diplomatic School in Bonn from 1981-1983. Mr. Krapp attended that Universities Muenster/Westphalia and Lausanne/Switzerland, Faculty of Law 1972 – 1978. He is married with three children.



Professor Juan Elias Chebly, Lead Adviser on Partnerships and Outreach to the UN Assistant Secretary General of the United Nations Environment Programme & Head of the UN Environment Management Group; Founder of Voipebox.com and GiveMe5.org. Prof. Chebly holds a BS in Management, a minor in International Business, a Finance MBA degree from St. John's University in Queens, NY and a Ph.D in Sustainable Development from Simon Bolivar University in Caracas, Venezuela. At age 24, he became St. John's Tobin College of Business youngest professor in 2010. In 2009, in founded Voipebox.com, a telecom startup introducing innovative and pioneering VOIP telephony solutions in South America and the US. Since 2013, he has been tasked to serve in different capacities as a report writer, researcher, programme manager, public speaker, strategic adviser, and community builder at the UN, at the juncture between academic research, policy-making,

and inclusive governance through partnerships and global outreach.



Ms. Dali Schonfelder, 17 year old, Founder & Co-Creator of NALU: Dress to Give. Ms. Schonfelder made many friends when traveling to rural India each year with her family. One year, she returned to find that the government had stopped paying for some of her friends' uniforms after they reached 12 years old. Since students were forbidden to attend school without uniforms, those who could not afford uniforms could no longer receive an education. Three years ago together with her younger brother Finn, she Cofounded NALU to break the poverty cycle and give students of all socio-economic levels the opportunity to stay in school. She oversees the process from start to finish, first designing the uniforms, and then traveling to India to lead their distribution. In a pilot program, NALU made and provided more than 6,500 school uniforms to children living in extreme poverty, resulting a doubled enrollment. Not only are more students

attending school, but academic performance has increased and teenage pregnancy in the village has decreased. Further supporting the community, NALU employs local tailors to manufacture the uniforms. To ensure the sustainability of their impact, she and her brother developed a business model by selling clothing and accessories. In the coming year, NALU's business revenue will provide 20,000 uniforms per month by 2020, creating long-term impact for rural India. She and Finn are NGOCSD-NY Honorary Advisers for Youth Leadership.
