H.E. Mr. Ib Petersen, Permanent Representative of Denmark to the United Nations

H.E. Mr. Ib Petersen is the Ambassador and Permanent Representative of Denmark to the United Nations in New York as of 1 August, 2013. Before taking up his new position, Ambassador Petersen served as State Secretary for Development Policy, of the Danish Ministry of Foreign Affairs, since 2009. Prior to this, he was State Secretary for Development Cooperation, Middle East, Africa, Asia, Latin America and the United Nations (2007-09). Ib Petersen has held a number of senior management positions in the Ministry of Foreign Affairs. He has also served on the boards of Danish International Investment Funds: The Industrialization Funds for Developing Countries and The Investment Fund for Central and Eastern Europe, and The Investment Fund for Emerging Denmark has been H.E. Mr. Ib Petersen is the Ambassador and Permanent

Europe, and The Investment Fund for Emerging Denmark has been named the Happiest Country in the World.



Consolee Nishimwe, Author

Consolee Nishimwe is a survivor of the 1994 genocide against Tutsis in Rwanda. Born in Western Province, she lived through the horrors of genocide at age 14. Consolee suffered physical torture during her three months in hiding, and miraculously survived with her mother and younger sister. In 2001 Consolee migrated to the United States where she has taken a progression of

United States where she has taken a progression of steps to overcome the multi-faceted traumatic events she suffered during the genocide and to chart a new course for her life.

In 2012, Consolee released her memoir Tested to the Limit: A Genocide Survivor's Story of Pain, Resilience and Hope. In recognition of her courage and accomplishments, Consolee was awarded the 2013 ASALH Living Legacy Award, the NSANGA STEP UP Service Award, and was recently listed in the ISSUU magazine by the Together for Girls Organization as one of 50 Global Heroes who help stop sexual violence against children in the world.

Dr. Kaiping Peng, Chair, Department of Psychology, Tsinghua University – China

Professor Kaiping Peng is a tenured faculty member at the Department of Psychology of the University of California at Berkeley. He received his Ph.D. in Social Psychology from the University of Michigan in Ann Arbor in 1997. Before coming to the US in 1989, he had been a faculty member at the Psychology Department of Peking University of China for five years. the psychology department of Beijing University, head of the social/ personality psychology area in Berkeley, member of the American Psychological Association Leadership Council, executive committee of the Institute of East-Asian Studies, steering committee for the Diversity Research at UC Berkeley, the co-president of the Fifth International Conference of Chinese Psychologists Worldwide, and numerous other national and international professional academic services. As part of the Berkeley-Tsinghua collaborative project, he was appointed as the founding chair of the Psychology Department of Tsinghua University in 2008. He also directs the Culture and Cognition Lab and the Berkeley Program of Psychological Studies in China at UC-Berkeley. He has published eight books and more than 100 articles and essays on cultural and social psychology, as well as methodological issues of psychology



Christina Stevens, Award Winning Author & Film Director

Christina was born in Sydney, Australia, fifth generation in a theatrical family and great granddaughter of Randolph Bedford, M.L.A. member of Parliament, publisher and lauded as one of the most colorful personalities in Australian letters and politics. It was this heritage and her

Dr. T. Hamid Al Bayati is a Professor at the Department of Political Science at Rutgers University. He was the Permanent Representative of Iraq to the United Nations from April 2006 to April 2013. He worked as the Deputy Foreign Minister for Political Affairs and Bilateral Relations from

2004 to 2006. During the same period, he headed the Iraqi Center for Strategic Studies. Dr. Al-Bayati was elected as the Chair of the Third Committee, related to Social, Economic, and Human Rights in 2006; the Vice President of the General Assembly in 2007; and the Chair of the Sixth Committee, dealing with legal issues, in 2008. Additionally, Dr. Al-Bayati was elected as the Chairman for the United Nations Disarmament Commission (UNDC) in 2011.

Kaylen is a 19-year old university student majoring in Global Studies and Political Science at South Dakota State University (SDSU) in the United States. She also

Kaylen served as the National President of Family, Career and Community Leaders of America (FCCLA), a non-profit career and technical student organization with over 200,000 members in 53 state associations (50 U.S. States, Puerto Rico, Virgin Islands, and DC). Because of her early involvement in FCCLA's youth health and safety programs, in 2010, Kaylen was chosen as a member of the first-ever Teen Distracted Driving Prevention Leadership Team, organized by the National Organizations for Youth Safety (NOYS). Kaylen was active as a volunteer in a Blue Cross Blue Shield initiative (Catalyst) that trained and provided resources for teens to become health activists in their own communities. She continues to be a youth health advocate through her involvement with NOYS. Most recently, as an intern for the Make Roads Safe Campaign for Global Road Safety, Kaylen created a short film to encourage youth to support "Safe Roads for All" as a priority in the United Nations MyWorld Survey for a Better World. Kaylen has been a youth leader for Global Youth Traffic Safety Month and the UN Decade of Action for Road Safety in the United States since the start of these activities in 2011.
